Dear Senators and Colleagues,

Before discussing the agenda of the upcoming plenary meeting of the Faculty Senate, I wanted to update you on an issue that is important to us as a College: the United States Presidential Executive Orders on immigration and refugees. During the February plenary, the Faculty Senate voted in favor of a resolution that expressed disapproval of this Executive Order; the resolution also asked for action on the part of our elected officials. With the assistance of CCNY Vice President for Government, Community and Cultural Affairs Karen Witherspoon, the senate resolution was forwarded to US Senators Gillibrand and Schumer and US Representative Espaillat. A copy of the correspondences appears below. The Executive Committee will continue to monitor the situation around the Executive Order and consider additional actions as necessary.

Attached please find the agenda for the next plenary meeting of the Faculty Senate on March 16, 2017. Interim President Boudreau has asked the Faculty Senate to approve a Strategic Plan for City College; a copy is provided below. Many College Faculty and Deans contributed to this draft, and it was shared with faculty and discussed in town hall meetings in Fall 2014.

Also on the agenda is the latest phase of the revision of the Faculty Senate Bylaws that was begun in 2013.

Lastly, I call your attention to openings in a number of College-wide efforts that require faculty participation. These are:

- 1) Faculty Ombuds;
- 2) The City College delegation to the University Faculty Senate (UFS);
- 3) Senate Affairs committee of the Faculty Senate.

Nominations for these open positions should be forwarded to Professor David Lohman (dlohman@ccny.cuny.edu) or myself (dj@ccny.cuny.edu). Elections to these open positions will be conducted by the Senate Affairs committee.

Let me also remind you that we need at least 34 senators to have a quorum for our meeting. I appreciate that this is a busy time of the year, but we need your participation as we deliberate important decisions affecting the future of the College. Please come and make sure that your voice is heard.

I look forward to seeing you on February 16th.

- 1. The meeting was called to order (2:12 pm)
- 2. Remarks of the Chair (2:14 pm)
- 3. Prof Jeruzalmi opened the meeting with a notice that, with the assistance of Vice President for Government Affairs Karen Witherspoon, he had sent the senate's resolution opposing the U. S. president's executive order on immigration to the appropriate elected officials, and that the office of Senator Gillibrand had responded favorably to the senate's letter. He then shared information about the transition to the virtual bookstore. He alerted faculty to a number of open positions on various senate committees, as well as an opening for a faculty member on the board of the Auxiliary Enterprise Corporation. The senate voted unanimously in favor of passing on a list of three nominated faculty for the president to choose among. "On behalf of nostalgia," Professor Crain expressed his regret at the loss of a physical bookstore on campus.

4. Report from interim President Vincent Boudreau (2:20 pm)

Interim President Vincent Boudreau began by clarifying that the decision to implement a virtual bookstore was part of a CUNY-wide transfer to Akademos. He then shared information about the upcoming codification of the state budget, and urged the senators that this is a good time to contact their representatives. Interim President Boudreau then officially announced a merger of Communications and Development. He also responded to faculty questions concerning the City College banners, the problem of securing the 21st Century Foundation moneys from misuse by future presidents, and the legal distinction between public and private space on campus.

5. Presentation of the City College Strategic Plan (2:39 pm)

Prof. Jeruzalmi explained that, although a Strategic Plan had been published last year, this plan had not been approved by the Faculty Senate. As a result, the Faculty Senate still need to approve a Strategic Plan in order to meet the specifications of our accrediting body, the Middle States Committee on Higher Education. Interim President Vincent Boudreau clarified the state of the various plans that had been proposed so far, and that one possibility would be to return to the "Deans's Plan". Interim Provost Driscoll warned that it would not be wise to approve a plan purely out of expediency. Associate Provost Cintron clarified the purposes of such a plan and the timeline for its approval. Prof. Moshary moved that the Executive Committee of the Faculty Senate appoint a committee and work with College administration and the plenary to revise the strategic plan, and bring it to the plenary for approval at the April plenary meeting. After more discussion, there was a motion to call the question which passed with no opposition and one abstention. The faculty then voted on the motion to have the executive committee appoint a group to review the various versions of the Strategic Plan. The motion was passed with no opposition and one abstention.

6. Report of the Faculty Senate Executive Committee (3:13 pm)

Prof. Renata Miller presented a Resolution to Improve the Status of Women at City College. Professor Miller read the resolution, and opened the floor for discussion. Following discussion as well as a number of minor amendments, the resolution was approved unanimously by voice vote.

7. Report from the Senate Affairs Committee (3:23 pm)

Prof. David Lohman presented a report on the revision of the bylaws. Professor Gutman clarified the revision process, and asked Senators to submit their proposed changes in the next two weeks. Professor Jeruzalmi thanked the Senate Affairs Committee for their hard work.

8. Report from the Ombuds (3:29 pm)

None.

9. Old Business (3:30 pm)

None.

10. New Business (3:30pm)

A new administrative change was announced that would prevent students from paying outstanding bills with credit cards. An upcoming union meeting was announced.

11. The meeting was adjourned at 3:32 pm.

I write to ask the Faculty Senate to consider the attached Strategic Plan for the Faculty Senate plenary's endorsement. Various draft plans have been presented to the Senate over the last few years for discussion, but it is my understanding that none of these plans has been voted on by the Senate.

The document I submit for your consideration is a framework document, developed as a way of presenting our larger goals and objectives for the college. As you know, this document was supplemented by an implementing document, breaking down these various objectives into smaller goals that could be pursued both college-wide and in the schools and divisions. I consider this implementing document to be incomplete, and as a college community, we need still to work to develop clear strategies to implement our broader objectives.

I ask you to vote on the framework document, however, because our Middle States Commission on Higher Education reaccreditation requires that we have a mission statement and strategic plan that has been approved by the appropriate faculty governance bodies.

I believe that the college should renew its strategic planning process after a permanent president is named. I hope, however, that the faculty will support this version of the strategic plan and mission statement as documents that serve broadly to define the college's work and identity until that time.

First, some news about our resolution on the US Executive Order on Immigration and Refugees. With the assistance of CCNY Vice President for Government, Community and Cultural Affairs Karen Witherspoon, the senate resolution was forwarded to US Senators Kirsten Gillibrand and Charles Schumer and US Representative Adriano Espaillat. The offices of Senators Gillibrand and Schumer responded to our note. I am also gratified to hear that implementation of a second related Executive Order has been blocked as of last nite and today.

Second, I would like to remind you of open positions for faculty:

- 1) Faculty Ombuds
- 2) The University Faculty Senate has reached out for nominations for three Senators to represent full-time faculty through May 2020, and one Senator to represent part-time faculty through May 2020.
- 3) Senate Affairs Committee has several vacancies.

Please send nominations to myself or David Lohman for these positions; The SA committee would like to move ahead with elections to these positions at the next plenary if possible.

At the last meeting, I also announced an opening for a member of the faculty on the AEC board. *The Auxiliary Enterprise Corporation* (AEC) at The City College of New York provides operational and administrative oversight over revenue-generating entrepreneurial activities at the college.

I have received interest from three faculty members (Peter Brass (GSOE), Patricia Kenyon (Science) and Marta Bengoa (Colin Powell) in being nominated to the President for him to pick a faculty member. Are there other nominations? If there are none, I would like your approval to forward these to the President.

Resolution to Improve the Status of Women at City College

- Whereas the 2015 COACHE Faculty Job Satisfaction Survey survey found that City College female faculty are by-and-large more dissatisfied than male faculty in numerous areas, including childcare, eldercare, and "institution does what it can for work-life compatibility;"
- And whereas City College seeks to provide equitable working and learning conditions that support its students, faculty, and staff in realizing their potential;
- Therefore, be it resolved that the Faculty Senate of the City College of New York urges the college to focus more attention on and to provide increased tangible and systematic support for women in the college community;
- Be it further resolved that the Faculty Senate shall form an ad hoc committee, consisting of faculty, staff, and administrators, to conduct a study of salary equity at City College; the administration should provide this committee with anonymized data on all faculty, executive compensation plan, and staff salaries, including titles, departments, number of years in title, gender, and race/ethnicity;
- Be it further resolved that the Faculty Senate of the City College of New York requests from the administration an inventory detailing campus services, including but not limited to health, counseling, and advising, that support the particular needs of students, faculty, and staff that identify as women; and
- Be it further resolved the Faculty Senate requests from the administration a timeline and plan for the reopening of the childcare center as a model of outstanding early-childhood education, with seats available not only for the children of students but also for the children of faculty and staff.

- C. At any time the Faculty Senate may modify its *ex officio*, non-voting membership by a two-thirds vote of the membership of the Senate.

- A. Each academic department is responsible for holding elections for its Senators
- B. Senators and Alternates shall be elected by persons of faculty rank in all departments of the following constituencies:

- C. Membership on the other Senate committees must include at least two Senators; otherwise members may be drawn from full-time instructional staff.
- E Committee members shall serve for a term of three years unless otherwise provided in these bylaws.
- E. Students who are members of Senate committees must be full-time registrants at the City College.
- F. The agenda for the regular meeting of the Faculty Senate in September shall provide for elections to fill all committee vacancies. In these elections, ballots shall be considered valid only if they are marked for as many candidates as there are vacancies to be filled. Except where otherwise provided in these bylaws, each valid vote for a candidate shall be given equal weight. After each of a committee's vacancies has been filled by this procedure, the nominee receiving the next highest number of votes will be designated as alternate to that committee with a term of one year. Alternates will be full participants in the affairs of their committees but without the power to vote (the latter being limited to regular members). The temporary absence of a voting member shall give the alternate a vote at the meeting or meetings in question. Alternates shall serve for the remainder of the academic year.
- G. Except as otherwise provided in these bylaws, committee members may be re-elected to serve on the same committee.
- H. Within three weeks after the newly elected or re-elected committee members have been notified of their election, all committees shall elect a chair and notify the Chair of the Senate of their choice.
- I The term of a committee member expires upon the election of a replacement. A committee, however, may remove a non-participating member. A committee member shall be construed to be non-participating if he or she is absent without excuse for three consecutive meetings or from one-third of the meetings in any semester. The committee chair shall notify the Chair of the Senate of the member's removal. Any member so removed may appeal his or her removal to the Executive Committee. In the event that such a member is removed from the committee, the Alternate automatically becomes a full member.
- J. Interim vacancies on both the Executive Committee and the Senate Affairs

ARTICLE V. ORGANIZATION AND MEETINGS OF THE SENATE

Section 1. Organization

- A. Immediately following the final plenary in May, the Senate that has been constituted for the next academic year, including the newly elected Senators, will convene a Reorganization Meeting.
- B. The only order of business for the Reorganization Meeting will be:
 - j) Report of the Senate Affairs Committee
 - ji) Election of the Secretary and the Treasurer for the next academic year iii) Election of the Executive Committee for the next academic year
- C. After nominations for the Executive Committee, Secretary, and Treasurer are closed, the meeting is adjourned for a recess. It reconvenes not as a plenary but for the purpose of voting. Votes must be counted in public by impartial persons, and must be completed in a single sitting and in view of Senators.

Section 2. Meetings

- A The Senate shall hold eight regular meetings during the academic year. The meetings shall be held on the third Thursday of the following months: September, October, November, December, February, March, April and May. In the event that the date for a meeting occurs on a day when the College is not in session, the Executive Committee shall set another meeting time or cancel the meeting for that month. The Executive Committee may reschedule a plenary of the Senate if, in its opinion, such a change would better serve the conduct of business by the Senate. The Executive Committee shall have the authority to cancel no more than one regular meeting during each semester.
- B. Notices of each meeting should be distributed at least seven days prior to the meeting.

 Such notices shall include the agenda and written statements concerning any policy matter to be presented at the meeting.
- C. Special meetings may be called by the President of the College, by the Executive Committee, or by written request of ten Senators (submitted to the Chair of the Executive Committee). The purpose of such meeting shall be explicitly stated in the notice of the meeting and shall be the only order of business.
- D. A majority of the total number of Senators, not including alternates, that comprise the plenum if there were no vacancies shall constitute a quorum. In order for a motion to be carried, it must receive an affirmative vote of a majority of the total number of Senators that comprise the plenum. An alternate Senator designated for each constituency (division or school) may vote in the absence of a regular member and count toward quorum requirements.

f. Shall receive request for community service which might be met by the College, and refer these to the appropriate body for action.g. Shall meet with such Community Advisory Committees as the

President may establish under Article XIII of the Governance Charter

Shall be composed of:

- 1. Seven members of the faculty elected by the Faculty Senate.
- 2. Two undergraduate students appointed by the Undergraduate Senate;
- 3. One graduate student appointed by the Graduate Student Association;

4. The Vice President for Communications and Public Affairs, Ex officio, without vote.

Section B. DUTIES AND COMPOSITION OF COMMITTEES

9. SENATE AFFAIRS COMMITTEE

I. Duties

- a. Shall constantly continually review and update the bylaws of the Faculty Senate.
- Shall be empowered to make automatic editorial changes in to the bylaws when those changers are without additional oversight.
 These types of changes include the following: nature
 - 1. Where a new title is given to When an ex officio member of the Faculty Senate and any changes accompanying is given a new title that title have has no substantive bearing on the work of the Senate, the title of that ex officio position in the Bylaws shall be corrected accordingly changed in the bylaws, and the Senate Affairs Committee shall inform the Senate of such changes. Bylaws conferring ex-officio membership shall be corrected accordingly.
 - 2. When where a change in the name of any a division, school, department, center, program or institute, or college-wide department which has ten or more full-time persons of faculty rank assigned to it does not involve any changes without any change in its governance change, the Senate Affairs Committee Bylaws Committee shall update the bylaws accordingly and inform the Faculty Senate.
 - 3. when When a department ceases to exist at the College, the Senate Affairs Committee Bylaws Committee will strike all delete all references to it in the bylaws and inform the Senate of those deletions.
- c Shall take full and complete charge of the oversee nominations and elections to the Senate and to the Office of the Ombuds.

Shall circulate notices concerning the nomination and election of Senators and of the Ombuds

- d. Shall certify to the Senate, at the May meeting, the names of elected Senators and of the Ombudsman to the Senate at the May meeting. Senators and of the Ombuds.
- e. Shall hear and decide upon complaints and appeals pertaining to elections under its jurisdiction. Appeals from decisions of the Committee can be made to the Faculty Senate Executive committee. Final appeals can be made to the Faculty Senate.
- f. The Committee may, at its discretion, conduct other elections, upon request, on behalf of other instructional staff group, such as the University Senate or the Faculty Welfare Trustees.

g. Shall prepare slates of nominees for all committees (except the Executive Committee and the Committee on Nominations) for the September meeting.

a. Shall consist of seven Senators.

Section B. DUTIES AND COMPOSITION OF COMMITTEES

10. DIVERSITY COMMITTEE

I. Duties

- a. Shall recommend policies to guide the College in fulfilling its responsibilities in maintaining diversity among faculty, students, and staff.
- b. Shall review the College's inclusion-oriented activities and efforts.
- c. Shall recommend means of improving communication between various groups and the faculty.
- d. Shall recommend procedures for the most effective implementation and coordination of the College's activities and programs in the above areas.

II. Composition

- a. Shall be composed of:
- 1. Seven members elected by the faculty, at least two of whom shall be Senators.
- 2. One undergraduate student appointed by the Undergraduate Senate;
- 3. One graduate student appointed by the Graduate Student Association;
- 4. The Dean of Diversity, ex officio, without vote.

Section C. COMMITTEE MEMBERSHIP

- a. Except as otherwise provided in these bylaws, each committee shall consist of seven members, at least two of whom shall be Senators.
- b. Membership on the Executive Committee and the Senate Affairs

 Committee the Nominations Committee and the Bylaws Committee
 shall be restricted to members of the Senate.
- c. Membership on the other Senate committees of the Senate must include at least one Senator; otherwise members may be drawn from full-time the entire instructional staff.
- d. Committee members shall serve for a term of three years unless otherwise provided in these bylaws. Their terms shall be so staggered that the term of office of approximately one-third of members shall expire each year.
- e. Students who are members of Senate committees must be full-time registrants at the City College.
- f. The agenda for the regular meeting of the Faculty Senate in September shall provide for elections to fill all committee vacancies. In these elections, ballots shall be considered valid only if they are marked for as many candidates as there are vacancies to be filled. Except where otherwise provided in these bylaws, each valid vote for a candidate shall be given equal weight. After each of a committee's vacancies has been filled by this procedure, the nominee receiving the next highest number of votes will be designated as alternate to that committee with a term of one year. Alternates will be full participants in the affairs of their committees but without the power to vote (the latter being limited to regular members). The temporary absence of a voting member shall give the alternate a vote at the meeting or meetings in question. Alternates shall serve for the remainder of the academic year.
- g. Except as otherwise provided in these bylaws, committee members may be re-elected to serve on the same committee.
- h. Within three weeks after the newly elected or re-elected committee members have been notified of their election, all committees shall elect a their chair men and notify the Chair Secretary of the Senate of their choice. All committee chairmen must be members of the Faculty Senate unless otherwise provided in these bylaws.

COMMITTEE MEMBERSHIP

i. The term of a member of a committee member expires upon the election of a replacement re-placement. A committee, however may remove a non-participating member. A committee member shall be construed to be non-participating if he/she is absent without excuse for three two consecutive meetings or from one-third

- a member is removed from the committee the alternate automatically becomes a full member
- j. Interim vacancies on both the Executive Committee and the Senate Affairs Nominations Committee shall be filled by nomination and election at the first plenary regular meeting following the occurrence of the vacancy, and shall be for the remainder of the unexpired term.
- k. Interim vacancies on other committees will be filled for the remainder of the academic year by their respective alternates. In the absence of an alternate, an interim vacancy shall be filled until the next regularly scheduled committee elections by appointment by the Senate Affairs Nominations Committee. Such appointments shall be immediately effective but must be confirmed by the Senate at its first subsequent regular plenary meeting. Vacancies occurring after the regular meeting of the Senate in March plenary of the Senate may remain unfilled.
- 1. Whenever elections for committees are held, additional nominations may be made from the floor by members of the Senate.
- m. The Chair of the Senate may serve ex officio on all standing committees.
- n. Standing committees may appoint ad hoc committees pertaining to matters under their supervision.
- o. It is the responsibility of the committee chair to ensure that all requirements of the Open Meetings Law (http://www.dos.ny.gov/coog/openmeetlaw.html) are met.

Section D. GENERAL

PROVISIONS

- 1. The Standing Committees of the Faculty Senate shall appoint the members of the Auxiliary Committees under their supervision, unless otherwise provided in these Bylaws, and shall create such new Auxiliary Committees as they shall deem necessary.
 - a. All appointments shall be subject to confirmation by the Faculty Senate.
 - b. The creation of new Auxiliary Committees shall be subject to confirmation by the Faculty Senate.
 - c. The size and representative character of the Auxiliary Committees shall be determined by the appropriate standing Committee unless otherwise provided in these Bylaws.
- 2. Each standing committee and each Auxiliary Committee shall elect its own chairman and such other officers as it may need.
- 3. Auxiliary Committees shall keep the appropriate Standing Committee informed of their actions and decisions.

Section D. SPECIAL COMMITTEES

- 1. When a vacancy occurs in the Presidency of the College, the Faculty Senate shall select the faculty members of an ad hoccommittee to advise with the CUNY Board of Trustees in filling the Office.
- 2. When a vacancy occurs in a college-wide office such as Vice President, Vice Associate Provost, Dean of Interdisciplinary Studies, the School of general studies and Chief Librarian, the Senate shall select the faculty members of an ad hoc committee to advise with the President in filling the vacancy.
- 3. When the need arises, ad hoc committees of the Senate may be proposed appointed by the Executive Committee Presiding Officer with approval the consent of the Senate, or may be proposed by and elected at the discretion of the Senate to serve for a definite purpose and for a definite length of time. A specific mandate for the proposed committee must be submitted in writing for approval by the Senate.

ARTICLE V ORGANIZATION AND MEETINGS OF THE SENATE

A. ORGANIZATION

B. MEETINGS

Section 1. The Senate shall hold eight regular meetings during the academic year. The meetings shall be held on the third Thursday of the following months: September, October, November, December, February, March, April and May. In the event that the date for a meeting occurs on a day when the College is not in session, the Executive Committee shall set another meeting time or cancel the meeting for that month. The Executive Committee may reschedule a plenary regular meeting of the Senate if, in its opinion, such a change would better serve the conduct of business by the Senate. The Executive Committee shall have the authority to cancel no more than one regular meeting during each semester.

Section 2. Notices of each meeting should shall be distributed at least seven days prior to the meeting. Such notices shall

include the agenda and written statements concerning any policy matter to be presented at the meeting.

Section 3. Special meetings may be called by the President of the College, by the Executive Committee, or by written request of ten Senators (submitted to the Chair secretary of the Executive Committee). The purpose of such meeting shall

ARTICLE VI VII AMENDMENTS

- Section 1. Amendments to these bylaws may be proposed by the Executive Committee, by the Bylaws Senate Affairs Committee, or by the petition of five Senators at any regular meeting.
- Section 2. Such Proposed amendments shall be read at two consecutive meetings and voted upon at the second meeting. tabled.
- Section 3. Such readings proposed amendments shall be part of the order of business of either the next regular meeting or a special meeting called for that purpose.
- Section 4. Notice of such amendments shall be distributed to all members with the agenda for the meeting.
- Section 5. Amendments to these bylaws require approval of two-thirds of the voting members of the Senate present at a meeting, provided that two-thirds represents a majority of the voting members of the Senate.
